This module is to be primarily used by the Grade IV Staff of all facilities.

Health facilities can log in using their existing credentials and access the BMW Module to perform the following actions:

a. **Log Form**: Record daily usage of biomedical waste bags, including the number of bags and total weight. Each submission generates a report that can be reviewed and retained for reference and compliance purposes.

b. **Report Status**: View and track previously submitted entries to monitor daily usage and ensure accurate record-keeping.
