The undersigned's office is pleased to inform you that the **Equipment Functionality of the Corporation Application** is scheduled for launch on 22nd September, 2024. This milestone represents a significant step forward in our ongoing efforts to transition the indent process for all medical-related requirements to a fully online platform.

The initial phase of the Module will cover **Basic Essential Equipment** (please refer to Annexure – I). Following this, the **Specialized Essential Equipment** will be launched to further enhance functionality and coverage.

We strongly encourage all concerned parties to begin utilizing the Equipment Functionality at the earliest. This system is designed to transform the **ordering and distribution process, ensuring greater efficiency and reducing the likelihood of errors.**

To facilitate a smooth transition, **the process for placing indents and issuing equipment will align with the existing procedures for drugs, diagnostics, and surgical items.** Health Facilities can access the application using their existing credentials and navigate to the **equipment section to map AMC, place indents, issue equipment, view stock, and receive supplies.**

Similarly, **District and State Warehouses will use the same login credentials as those for diagnostic and surgical processes. The workflows for indenting, issuing, receiving, and stock management will mirror current procedures, with equipment-specific functionalities integrated accordingly.**
