- 1. All Indents from Hospitals from the 3rd of June, 2024 onwards will be redirected to the State Warehouses.
- 2. All Issuances towards these indents made by these Hospitals from the 3rd of June, 2024 onwards will be fulfilled by the State Warehouses.
- 3. All Indents which have been raised by Hospitals before the 3rd of June, 2024 will be fulfilled by the respective District Warehouses until completely issued.

This process has been implemented to further improve the supply chain distribution and overall user satisfaction and experience. To ensure a seamless transition, the process of placing indents and issuing for drugs and diagnostics will follow the same process as currently being used with no changes in the actual process and no change in logins.
