- 1. It may be further stated that, Floriemina Solutions did not provide all necessary documents for their qualification, hence the tender was summarily rejected and was not processed further for technical specifications checking.
- 2. Arengh Medical Supplier has provided all necessary documents, the technical specification also complies with the requirement as per tender documents. Hence, their bid is accepted.
- 3. Digital Hardware did not provide the necessary documents as stated above; however, they requested that the documents be provided before the financial opening. Additionally, the technical specifications for the UPS comply with the requirements as per the tender documents.
- 4. Marak Supply Agency did not provide necessary document as stated above, however, they requested that the documents can be provided before financial Opening and for the personnel employment they mentioned they will hire in the future, the technical specification for UPS also complies with the requirement as per tender documents



After a thorough review by the Tender Committee members based on the above observations, it was decided that Arengh Medical Supplier, Marak Supply Agency and Digital Hardware may qualify for the financial bid opening, provided they submit the remaining documents within 3 days or before the date of financial bid opening.
