However, hard copies of test reports will be available with the collection center/laboratory as per operational feasibility. Moreover, samples should reach to the Lab within 24 hours from the time of collection.	In adherence to the guidelines stipulated by the Central TB Division, it is imperative to ensure that collected samples reach the laboratory within the designated timeframe of 8-30 hours. Timely submission is paramount as it ensures the viability of white blood cells, thereby optimizing the accuracy of diagnostic procedures.
